

Providing Access to Early Years Services

“On average, **19%** of children in Ontario access early year programs and services at Best Start Hubs.” *Dr. Jean Clinton*

In Lambton County, **39%** of our children are accessing programs and services at our Best Start Hubs.

Priorities Moving Forward 2016-2017

- Conduct a local needs assessment and inventory of existing child and family programs and services
- Engage parents and caregivers to inform the planning and delivery of Ontario Early Years Child and Family Centres (OEYCFC) programs and services
- Ensure strong connections between community planning tables (Lambton Refugee Sponsor Network, Working Together for Kids Mental Health, Special Needs Strategy, Child Care Supervisors, Education, Community of Practice) to inform service system planning
- Promote early identification of children under the age of 3
- Continue to increase understanding of indigenous cultures and traditions through networking and sharing
- Improve the system-wide approach to further support indigenous families by providing training, networking and partnering with area agencies
- Support the development of a community business plan for a community hub for youth

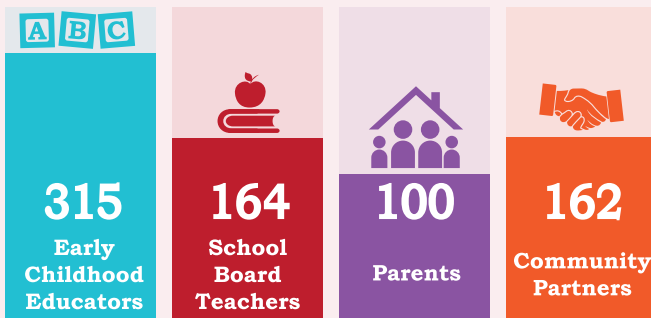
How do we implement the above priorities with:

Parent & Professional Resource Centre

The LCPN supports, and the County of Lambton funds the Parent and Professional Resource Centre (PPRC) operated by Lambton College. In 2015 there were 741 members, participating in 71 Professional Learning events. The focus has moved from professional development to professional learning, with an emphasis on pedagogy and reflective practice. The “How Does Learning Happen” study group now meets monthly, at the request of participants to discuss and reflect on current research, pedagogy, and learning environments, with a focus on foundational relationships in the early years. Much work has gone into supporting Child Care Supervisors to mentor their staff in understanding the Child Care and Early Years Act (CCEYA), program statements, policies and regulations.

Lambton County Quality Assurance Commitment

The Children’s Services Department is committed to enhancing quality early learning experiences for children and families in Lambton County. A Quality Assurance Working Group was formed, made up of Child Care Administrators and Community Partners, to look at the present tools being used to support quality child care environments. The consensus was that the current tools were outdated and not reflective of “How Does Learning Happen”. After examining several options, the group decided to adopt the National Quality Rating Tool of Australia. Permission was obtained to use the framework and adapt it to the Standards of Practice for Early Childhood Education and CCEYA program statements. The Rating Tool will assist Early Childhood Educators to document and support learning in environments for children birth to twelve years. Eight programs are presently involved in a pilot of the tool and training to the broader community is expected to begin in late Fall 2016.



The Lambton Children's Planning Network (LCPN) represents Lambton's commitment to working and planning together to support the early learning, health, and wellbeing of each child with the long-term view of enriching the quality and capacity of future generations.
